



STUDENT AND FAMILY HOMESTAY AGREEMENT FORM

This homestay agreement is between _____ (Foreign Exchange Student, hereafter called "STUDENT") and _____ (Calvary Schools of Holland Host Family, hereafter called "FAMILY")

The STUDENT will abide by the following house rules:

- STUDENT will seek permission from the FAMILY for attending activities and events outside of the normal scope of the FAMILY routine.
- STUDENT will assist with chores around the house as requested by FAMILY.
- STUDENT may not bring or have in possession at any time any inappropriate reading or electronic materials in the home. FAMILY reserves the right to check STUDENT'S room at any time.
- STUDENT agrees to make reparations to the FAMILY for any financial damage or injury to the person or property of others that he may cause.
- STUDENT will pay for any personal expenses, special personal care products, cell phone, and international calls.
- STUDENT agrees to abide by all of the rules stated in the Calvary Schools of Holland student agreement, the State of Michigan, and the United States.
- The use of illegal drugs, tobacco products, and alcoholic beverages is expressly forbidden. STUDENT understands that misbehavior or non-compliance to family, school, or state rules may result in consequences decided by the Host parent and/or school or government officials up to and including discharge from Calvary Schools of Holland and return to home country
- STUDENT agrees to pay for all school-related fees such as sports, transportation alternatives, student fees, and other school related special events.
- STUDENT will make school attendance a priority, and make a concerted effort to make satisfactory academic progress.
- STUDENT is required to have medical insurance in place prior to arrival and agrees to pay for any medical expenses during their stay.

Calvary Schools of Holland will pay the FAMILY a stipend (if eligible), beginning in September and continue to do so on the same day of each following through June of the following year. This payment will discontinue if STUDENT is discharged from Calvary Schools of Holland on/before the end of the school year. Payment will discontinue on the month after discharge.

The FAMILY agrees to provide the following:

- FAMILY will provide three meals a day.
- FAMILY will provide transportation to and from school and school events, as needed and available. This might include riding the school bus if available.
- FAMILY will provide a private bed and space to complete homework.
- FAMILY will not place STUDENT in a room with a child younger than 13 years old or of the opposite gender. FAMILY will only place STUDENT in a legal and safe bedroom.
- FAMILY will provide internet access.
- FAMILY will provide a warm, nurturing and caring Christian family environment.
- FAMILY will help with school questions and homework as needed to the best of their ability.
- FAMILY agrees to provide transportation and assistance for seeking medical care if needed.
